 - The study explores how Greece’s healthcare system can adapt to rapid demographic aging and technological change. With over one-third of the population expected to be over 65 by 2050, the study anticipates rising chronic illness and pressure on health services. Using strategic foresight tools, expert interviews, and future labs, it identifies policy pathways to strengthen system resilience. Emphasis is placed on integrating innovations like telemedicine and AI, enhancing workforce skills, and fostering a culture of prevention. The study offers actionable recommendations to harness technological opportunities and ensure sustainable, equitable healthcare delivery for Greece by 2035.

- The ongoing economic crisis in Greece has had widespread effects; among the most alarming have been the effects on the population's health. The goals of the research proposed are to: identify individuals and families from the most disadvantaged neighborhoods of Athens that are weathering these effects successfully, document coping strategies they employ, and investigate determinants of their success. This research will be complemented by teaching a graduate course at the National and Kapodistrian University of Athens on "Communication, Communities, and Health," with an emphasis on the relationship between economic crises and health, by lecturing in courses at Panteion University, and developing seminars in collaboration with the Greek National Center for Social Research (EKKE).

Developing a Rutgers Model for Training a New Generation of Global Health Communication Researchers and Professionals (2023-2025)

Funded through the *Rutgers Global Health Institute*. Health communication is an essential component of global health and international development. Recent epidemics and climate change-related disasters have created the need for a diverse global health workforce that can implement evidence-informed principles, strategies, and planning of health communication interventions. The competencies and skills needed to perform this work go well beyond design and dissemination of health messaging to include competencies related to community and stakeholder engagement, building and sustaining effective partnerships, and using research in strategic and operational

decision-making. However, an interprofessional program capable of delivering 21st century health communication training at scale is not yet available. The goal of this project is to lay the foundation for creating such a program at Rutgers. The project will include needs assessment research, such as interviews with key internal and external stakeholders to understand key health communication needs across various global settings and to define the critical communication, information, engagement, research use, and leadership competencies needed to promote greater health equity and systems-change in the global health context. The project team will develop a core training plan as well as engage in international concept testing, specifically in Greece, where the population and health care system have battled challenges related to a 10-year-long economic recession and an ongoing refugee crisis.

Can Digital Health Technologies and Data Science Transform Health Professional Practice and Communication, and Ensure Health Equity? (2022-2025)

\$49,964

- Funded through the *SC&I Scholarly Futures* grant mechanism. Through this pilot study, we aim to contribute to a growing multidisciplinary research on the impact—realized and possible—of the adoption of new communication and information technologies (e.g., wearables, smart phones, EHRs, digital pharmaceuticals) by healthcare providers and organizations on, among other things, patient safety, adherence to prescribed treatment, and patient-provider relationships. From an organizational standpoint, the literature suggests considerable interest in how such digital tools can improve diagnostic ability and work efficiency. In this context, our team is particularly interested in the potential of digital health tools to both exacerbate and mitigate health inequities. In this first phase of this pilot study, our goal is to interview patients that depend for their care on healthcare facilities in socio-demographically diverse New Jersey communities served by Rutgers, as well healthcare providers, including physicians, physician assistants, and nurse practitioners. Findings from this first stage of the study will inform a second stage, in which we will employ a two-phase stakeholder elicitation process based on a modified Delphi method. This method allows us to identify how patients and clinicians collectively perceive uses of these digital technologies (for example, as effective or not, as feasible or not) and strategies for their adoption and also attain consensus amongst these two stakeholder groups. Findings from this study will be shared and discussed with all healthcare organizations that collaborate with us. Findings and discussions with collaborators will inform best practices and future policy choices.

Rutgers Global Study Abroad Curriculum Integration Grant (2020-2022)

II. GRADUATE LEVEL COURSES (M.A. & Ph.D.)

Interprofessional Practice and Communication in Healthcare, in the U.S. and Greece (Course Part of Graduate Study Abroad Program: Summer 2025)

*Taught applying Collaborative Online International Learning (COIL) and Team-Based Learning approaches.

*In Collaboration with Democritus University of Thrace (Alexandroupolis, Northern Greece)

Description: Interprofessional education, practice and communication are key to improving patient outcomes, better preparing the future healthcare workforce, and imbuing healthcare systems with the capacity to learn and adapt to changing needs. According to the 2022 U.S. Joint Commission's Sentinel

Event Annual Review, communication breakdowns continue to be the leading factor contributing to sentinel events. The issues that the Joint Commission highlighted are pressing globally. The World Health Organization has also underscored the need to promote interprofessional education, which it has defined as the learning that “occurs when two or more professions (students, residents, health workers) learn with, about and from each other to enable effective collaboration and improve health outcomes” (WHO, 2010). This program, co-designed by faculty from Rutgers University in the U.S. and Democritus University of Thrace in Greece, aims to equip healthcare professionals and other experts in the two countries with the tools they need to better address the aforementioned challenges.

Research Design (Course First Taught, Fall 2023)

**Taught face-to-face for Ph.D. students.*

Description: Research design refers to the strategy researchers develop and implement to investigate the phenomena in which they are interested. Hence, the first part of the course will focus on an overview of general approaches to research design, and the role of theory and paradigmatic assumptions in its development. Key aspects of research design will be discussed next, followed by an examination of how we develop research questions and hypotheses. Subsequently, we will discuss a broad array of methods, including established and newer, but also approaches to research design that involve multiple and mixed methods. We will conclude with a series of classes around data analysis and interpretation, as well as the presentation of research findings to diverse audiences. Throughout the semester, we will have the opportunity to speak with several faculty members from Rutgers University and beyond about current projects and their approach to research design. Additionally, over the course of the term and in stages, students will develop and present their own complete research project.

Health Communication & Health Inequalities Across the Health Professions in Greece and the U.S.A. (Course Part of Graduate Study Abroad Program: Summer 2022 & Summer 2023)

**Taught applying Collaborative Online International Learning (COIL) and Team-Based Learning approaches.*

**In Collaboration with Hellenic Mediterranean University (Crete, Greece)*

Description: Health inequities—avoidable and systematic differences in health outcomes—affect marginalized groups worldwide, including women, ethnic and racial minorities, LGBTQI individuals, immigrants, refugees, and those with low socioeconomic status or disabilities. These disparities are driven by factors like discrimination and unequal access to healthcare, education, and resources. This program uses a socio-ecological approach to examine how health is shaped by individual traits, interpersonal relationships, organizations, communities, and policy environments. Special emphasis is placed on communication—both as a health outcome and as a process that shapes health behaviors—and on the role of technology in transforming healthcare interactions. Through case studies in Greece and the U.S., students will explore how inequities manifest in various healthcare contexts, including doctor-patient and interprofessional communication. The program prioritizes affected populations such as rural residents and low-income communities. Students will apply their learning by collaborating on real-world projects that diagnose public health challenges and propose community-based solutions with faculty support.

Health Communication (New Course Proposal Submitted & Approved for MHCI Program in 2022)

**Taught in face-to-face, online, hybrid modes.*

Description: The course is designed to introduce students to major areas of research and professional practice in the field of health communication, including: (a) patient-healthcare provider communication, (b) inter-professional communication in healthcare, (c) multilevel health promotion campaigns and interventions, (d) multi-/inter-cultural health communication, (e) e-health, m-health, and telehealth applications, and (f) risk and crisis communication, among others. Through a

combination of readings, case studies, and assignments students will grapple with and apply key concepts, theories, and methods used to analyze health communication phenomena and address related real-world problems. Students will also learn how to find, analyze, interpret, and evaluate empirical health communication research.

Health Communication Campaigns & Interventions (New Course Proposal Submitted & Approved for MHCI Program in 2022)

**Taught in face-to-face, online, hybrid modes.*

**Syllabus adapted from Dr. Itzhak Yanovitzky.*

Description: This course considers the design, implementation, and evaluation of public health communication programs that aim to influence the health-related behaviors of individuals, groups, and communities. The first part of the course reviews the theoretical foundations of public health communication campaigns, including key theories of health behavior change and communication theories that augment them. The second part introduces students to key planning and design considerations of successful public health communication campaigns. The third and final part of the course engages students with the versatile communication strategies and skills that health communication professionals employ routinely to influence people's health-related decisions and behaviors. Students gain first-hand experience with the process of designing a campaign to address an actual public health problem by completing a sequential set of individual assignments and group tasks.

Communication, Communities, and Health

Description: Evidence of renewed interest in the study of how the places we live in impact our health can be found across many disciplines, ranging from sociology and public health to geography and economics. This course emphasizes the contributions of communication to this line of research. By the end of this course, students are able to (a) evaluate theoretical and methodological frameworks developed to address community health issues; (b) generate theory-driven research designs to address pressing health issues of communities, and (c) conduct formative research required to implement their research plans.

Health Literacy: Patients, Organizations, & Societies

**Available in traditional and blended/hybrid (online and in-class) formats. Taught employing a Team-Based Learning [TBL] approach.*

Description: In a society where the health system has grown increasingly complex and difficult to navigate, and where people may have instant access to information from multiple sources, health literacy has become a major issue. By the end of this course, students are able to: (a) Define health literacy, explain the key differences among the various ways in which the concept is used, and articulate why reducing health literacy-related disparities is important; (b) articulate the advantages and disadvantages of existing measures, and discuss challenges to improving assessment of health literacy; (c) explicate the factors that shape individuals' health literacy and discuss how it is implicated as a factor that shapes individuals' health; (d) articulate how health literacy is shaped by the many contexts in which individuals seek to address health-related concerns, including that of the family, of healthcare organizations, the communities in which they live, the societies of which they are part; and (e) critically review and evaluate campaigns, and interventions designed to address health literacy disparities.

Theories and Research in Organizational Communication

Description: This course is designed to provide an overview of classical, contemporary, and emerging organizational communication theorizing. Readings and assignments are selected to demonstrate alternative frameworks for understanding organizational phenomena and processes, and to provide

opportunities to apply these approaches to analyzing various situations, which individuals, groups, organizations, and populations of organizations face in the course of their everyday lives.

III. UNDERGRADUATE LEVEL

Introduction to Communication & Information Processes (*with Health & Wellness Focus*)

(First Taught, Spring 2026)

**Taught in HyFlex format*

Description: This survey course introduces students to the major areas of the communication discipline. We will explore the meaning of communication, the importance of foundational communication theories, and assess the role of interpersonal, group, organizational, mediated, and mass communication in global contexts.

Health & Communication Technology (First Taught, Spring 2023)

**Course designed in collaboration with Dr. Christos Diou, Assistant Professor of Artificial Intelligence and Machine Learning, Department of Informatics and Telematics, Harokopio University of Athens, Greece.*

**Taught applying a Collaborative Online International Learning (COIL) approach.*

Description: The class explores the many ways information and communication technologies (ICTs) have changed and continue to transform health information seeking in our everyday life, patient-healthcare provider interactions, healthcare delivery and healthcare organizations' processes and practices, health promotion campaigns and interventions, and health-related policymaking. Throughout the semester, the class will examine factors that shape adoption and use of new ICTs, as well as these technologies' social impact, with an emphasis on health. In so doing, faculty and students will analyze the potential of ICTs to reduce health disparities, but also their potential to exacerbate health inequities. To facilitate understanding, students will be introduced to representative examples of key technologies related to Electronic Health Records, telehealth, health data representation and storage, data science, artificial intelligence and machine learning. Through a combination of readings, case studies, and assignments students will grapple with and apply key concepts, methods, and tools to examine the relationship between ICTs and health, and to address related real-world problems.

Communication Theory (First Taught at Rutgers, Spring 2023)

**Taught face-to-face*

Description: This course examines basic concepts, models, and theories that examine the role of communication in human behavior. First, basic elements in the communication process are examined. Then, communication as it occurs in the context of interpersonal relationships, small groups, organizations, media, and intercultural interactions is reviewed. Several theories in each area of the communication discipline will be covered. Through the readings, lectures, and writing assignments planned for this course, you should come to better understand the process of human communication and see it applied in your daily interactions and activities.

Health Messages & Campaign Design

**Taught in face-to-face, online, hybrid modes*

Description: This course considers the design, implementation, and evaluation of public health communication programs that aim to influence the health-related behaviors of individuals, groups, and communities. The first part of the course reviews the theoretical foundations of public health communication campaigns, including key theories of health behavior change and communication theories that augment them. The second part introduces students to key planning and design considerations of successful public health communication campaigns. The third and final part of the course engages students with the versatile communication strategies and skills that health

communication professionals employ routinely to influence people's health-related decisions and behaviors. Students gain first-hand experience with the process of designing a campaign to address an actual public health problem by completing a sequential set of individual assignments and group tasks.

Communication, Technology, & Health in 21st Century Cities

**Taught employing a Team-Based Learning [TBL] approach*

Description: Interest in how the cities we live in impact our health and well-being has intensified in the past 15 years across the social sciences and in communication more specifically. In this course students will be introduced to the relevant multidisciplinary literature, but will focus on how communication and technology shape urban residents' health. Additionally, students will work with the instructor and their peers in class to (a) identify pressing health-related issues that nearby urban communities are facing and (b) develop and propose research-based solutions. Specific topics that will be addressed in class include: the built environment and urban health, the health-related effects of climate change, smart cities and quality of life, the role of communication technologies in urban health, communication disparities and health inequalities, media and health, food deserts and urban food production, methods for diagnosing and addressing urban health challenges.

Ethnic Media

**Course taught employing a Team-Based Learning [TBL] approach*

Description: This course explores how media produced by ethnic communities, for ethnic communities affect ongoing negotiations of identity, perceived lines of division between 'us' and 'others,' and how the production and consumption of ethnic media affects the character of the larger media and societal landscapes. Historical, policy, cultural, organizational, professional, social relations, community, migration, and globalization dimensions of the study of ethnic media will be addressed through readings, individual and group projects, as well as case studies from the U.S., Europe, Australia, and beyond.

Communication and Global Organizations

**Course taught in classroom and as a fully online course (employing a Team-Based Learning [TBL] approach)*

Description: Through a series of readings (including academic articles, research reports, and case studies), but also media content (whenever appropriate and possible), instructor and students investigate what globalization is and how it is transforming organizations across the world. The course is designed to enable students to understand why and how communication is a critical process through which these transformations are taking place. Students explore, for example, how new communication technologies have led to the emergence of network, virtual, and web organizations, and what the implications of these developments are for both organizations and the individuals that are part of them (e.g., as employees, clients). Additionally, students and instructor discuss how globalization is shaping the landscape not only of private sector organizations (that is, corporations), but also public sector organizations (e.g., government-related) and a growing number of non-governmental organizations (NGOs) and non-profits.
